- The grant for recognition is not extendable and does not in any way imply any obligation to recognize/affiliate beyond Class VIII.
- The School shall abide by the provisions of Right of Children to Free and Compulsory Education Act, 2009 (Annexure I) and the Right of Children to Free and Compulsory Education Rules, 2009 (Annexure II).
- 3. The School shall admit in class I, to the extent of <u>25%</u> of the strength of that class, children belonging to weaker section and disadvantaged group in the neighbourhood and provide free and compulsory elementary education tillits completion. Provided, further that in case of preprimary classes also, this norm shall be followed.
- For the children referred to in paragraph 3, the School shall be reimbursed asper Section 12(2) of the Act. To receive such reimbursements school shall provide a separate bank account.
- The Society/School shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure.
- 6. The School shall not deny admission To
 - any child for lack of age proof.

- (vii) The teacher performs its duties specified under section 24(1) of the Act and
- (viii) The teachers shall not engage himself or herself for private teaching activities.
- The School shall follow the syllabus on the basis of curriculum laid down by appropriate authority.
- The School shall enroll students proportionate to the facilities available in the school as prescribed in the section 19 of the Act.
- 10. The School shall maintain the standards and norms of the school as specified in section 19 of the Act. The facilities reported at the time of last inspection are as given under:-
